BOOKING CONDITIONS

The payment on account must without fail accompany the booking. It will be deducted from the total cost of the stay (except the booking / reservation fee). The booking / reservation will become effective after our confirmation and the return to you of the confirmation copy of that booking.

All residents and visitors are responsible for taking good care of the properties.

Dogs of category 1 and 2 are not permitted. Not more than two animals are permitted for each let. They must: be kept on a leash; have been vaccinated against rabies, tattooed or carry an identity chip; not be left unaccompanied, and be accompanied off-site for their needs.

In case of cancellation up to two months prior to the beginning of the let, the whole of the account payment will be reimbursed. Between the 60th. and the 30th. day, 50% of the account will be reimbursed. After this time the whole of the payment for the let becomes due. Cancellations must be made by registered mail, the post mark being the effective date. However, in each case the booking fee will be retained.

'No Show'. If the hirer does not appear within 24 hours of the reservation or booking, without explanation, the management reserve the right to dispose of the booking on the assumption that the client has unilaterally cancelled.

In case of late arrival or early departure, the entire booking fee remains fully payable.

A deposit of €150 is taken on arrival, but not encashed, and returned / repaid on departure subject to deduction for damages and / or breakages if any. This deposit is not the limit of the hirer's responsibility. The hirer should be covered by a public liability insurance policy.

Each chalet is fully equipped with kitchen utensils, tableware and bedding (with the exception of linen and towels unless they have been separately hired). A full inventory may be seen and checked for anomalies on arrival.

The cleaning of the accommodation is the responsibility of the hirer. At the end of the stay, the chalet must be cleaned to the same condition as when taken over at the beginning of the let. Otherwise a sum of €50 will be required to be paid or deducted from the deposit.

Payment in full is due on arrival.
